Recite the Pledge of Allegiance.

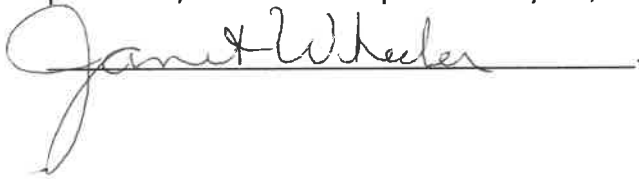
Observe a Moment of Silence.
